presently extremely slow.

agreement.

Dear Sir,

Greetings from Solar Power Developers Association.

At the outset, SPDA would like to thank MNRE for introducing the Dispute Resolution Mechanism (DRM) for faster settlements of contractual disputes. However, we would like to bring to your kind notice some of the critical issues that Solar Power Developers are facing with the DRM process.

### 1. Modifications to the DRC recommendations:

The Ministry of New and Renewable Energy ("MNRE") vide its order dated 18.06.2019 issued setting up a Dispute Resolution Mechanism to consider the unforeseen disputes between solar/wind power developers and SECI/NTPC, beyond contractual agreement. The relevant excerpt is reproduced below:

"3. (v): The recommendations of the Dispute Resolution Committee' (DRC), along with MNRE's observations, will be placed before Hon'ble Minister (NRE) for the final decision. The Ministry shall examine and put up such recommendations to Minister (NRE) with the comments of IFD within twenty-one (21) days of receipt of the recommendation from the DRC."

It may kindly be noted that DRC gives its recommendations after allowing the developers to present their case. These recommendations are given after due diligence and following the principles of natural justice.

### Request:

Hence, the recommendation from the competent authority should be accepted without any modification by MNRE.
