## NOTE:

- 1. SPDA provides a list of international Solar power developers to RE-invest India.
- 2. SPDA to be a member of the committee for Unified bidding guideline shall be placed on MNRE website shortly.
- 3. MNRE planning to shortage of solar glass in the country Importing is not a restriction from MNRE, anti-dumping duty is imposed on solar glass, only one manufacturing in India. 2-2.5 GW glass manufacturing in India, 16 GW module manufacturing in India
- 4. 400 MW RTC tender any energy generation beyond capacity is allowed to be sold to third party or any other source. In such a case, there should be any issue with connectivity capacity more than the contracted capacity.
